B. <u>ELIGIBLE CONDITIONS FOR MANUFACTURER(S)</u>:

- 1. The applicant shall be Original Manufacturers of the Tractors.
- 2. The applicant shall submit original Manufacturing Company Registration Certificate.
- 3. The manufacturer has to submit documentary evidence establishing their ability to supply the Tractors in 30 Days with respect to the manufacturing, supply and delivery of tractors including transportation, commissioning, registration with insurance to various villages in the state of Andhra Pradesh
- 4. The applicant shall be Manufacturers having Certificate Part II or 05 years of completed experience with workshop license for manufacturing as specified in the schedule for supply of different types of Tractors.
- 5. The Manufacturer shall submit recent power tariff bill of the manufacturing unit in proof of the unit in running condition.
- 6. The Manufacturer shall submit the labor certificate.
- 7. The Manufacturer shall submit the recent GST invoices of last 06 months anywhere in the state of Andhra Pradesh.
- 8. The Manufacturer(s) shall have a full-fledged manufacturing unit with sufficient personnel for manufacturing of above Tractors as per the prescribed specifications.
- 9. The Manufacturers shall have GST, Registration and PAN/TAN/TIN number and Manufacturing Companies shall regularly furnishing information to GST Authorities.
- 10. Failure to satisfy the mandatory conditions, the EoI will be summarily rejected.
- 11. The Manufacturer shall have to submit FMTTI certificate approved by the Central Farm Machinery Training and Testing Centre, Budni, Madhya Pradesh for the model quoted.

C. Eligibility Criteria for the acceptance of EoI

2. Physical Requirement:

Manufacturer should have supplied, tested and delivered minimum of **600 No. of** Tractors of the model quoted to Govt/semi Govt/Local Bodies in the State of Andhra Pradesh in any single year in last 5 years i.e., from 2018-19,2019-20,2020-21,2021-22 and 2022-23.

(Supporting experience/ Completion/ performance certificates issued by the competent authority of Government Organizations only to be submitted)

3. Service Centers:

- **3.1** The Manufacturer shall have full fledge minimum 50 No of Service centers covering all the 26 dist. of AP to attend post sales and service. District wise list with Name and locations needs to be attached with EoI.
- 3.2 Manufacturer needs to ensure the availability of sufficient no. of spare parts in all the authorized service centers. Self-attested certificate to be attached along with EoI.
- **3.3.** Furnished false / fabricated particulars in the forms, statements and /annexures submitted in proof of the qualification requirements and/or not turned up for entering into agreement, when called upon.
 - record of poor progress such as abandoning the work, not properly completing the contract, inordinate delays in completion, litigation history or financial failures etc shall be submitted as per prescribed format (Annexure-V)
 - participated in the previous bidding for the same work and had quoted unreasonably high EoI percentage and
 - even while execution of the work, if found that the work was awarded to the Manufacturing Company based on false/fake certificates of experience, the manufacturer will be blacklisted and work will be taken over invoking clause 61 of PS to APSS.

4. One EoI per Manufacturer:

- **4.1.** Each Manufacturer shall submit only one EoI for the work. A Manufacturer who submits more than one EoI will cause disqualification of all the EoIs submitted by the Manufacturing Company.
- **4.2.** The Authority reserves the right to accept or reject all or any of the EoIs without assigning any reason whatsoever.

D. <u>INSTRUCTIONS FOR SUBMISSION OF EOI SCHEDULE:</u>

1.	The Manufacturer(s) shall submit EOI Schedule with all documents indicated in technical
	specifications (Annexure-II) in a separate sealed cover duly superscribing "Technical
	Schedule for the tractor model "and Price quote as per (Annexure-
	III) in a separate sealed cover duly superscribing "Financial Bid for the tractor
	model" with name and address of the Manufacturer. Both Sealed
	technical & Price Bid covers shall be placed in a sealed cover before submission duly
	superscribing EoI for supply of Tractors.

- 2. The Manufacturer shall submit EoI schedule along with their model technical specifications as mentioned in **Annexure-VI**
- 3. The Manufacturer shall submit their application on or before 27-02-2024 at 4:30 PM duly enclosing demand draft of Rs.1,00,000/- towards nonrefundable application cost. Application without DD will be rejected. The eligible manufacturer after empanelment shall deposit Rs.10,00,000/- (Rupees: Ten Lakhs only) as Performance Guarantee Deposit at the time of submission of Agreement. The DD pertaining to Performance Guarantee shall be drawn in shape of DD in favour of APSAIDC Ltd., payable at Vijayawada. The deposit amount shall be refunded without interest as per the request of the successful bidder after completion of warranty period and which will not be refunded within one year.
- 4. The Manufacturer(s) shall submit duly notarized declaration along with EOI, as per the proforma furnished in **Annexure-IV** on Rs.100/- non-judicial stamp paper.
- 5. The authorized person (representing the Manufacturers/Directors/Senior employee who can take decisions on behalf of the company) shall invariably attach authorization letter obtained from the competent authority as per rules of the company, to sign and to participate in the empanelment process.
- 6. The price quotations of the manufacturers whose application is technically qualified will only be opened and after opening of the price list, if it is found that the rates quoted are high and are not acceptable, the Technical Committee shall have the right to go for negotiations.
- 7. The proof of attested copies of the documents regarding the status of the manufacturing company should be attached to the Application
- 8. Only representative from Manufacturers with the authorization letter and valid identity is allowed to participate in the Empanelment Process and the company intending to apply should ensure the same.

E. GENERAL TERMS AND CONDITIONS:

- 1. The Expression of Interest (EOI) applications can be downloaded from website i.e., www.apagros.org
- 2. The Manufacturer(s) have to quote the prices for the model as per technical specifications.
- 3. Negotiations will be held by the State Level Technical Committee at O/o VC & MD, APSAIDC Ltd., Vaddeswaram.

- 4. The agreement period will be up to one year from the date of signing the agreement. No Escalation charges will be paid for supply of Tractors during the agreement period. Failure to supply the Tractors due to price variation will attract blacklisting of the Manufacturing Company and shall not be allowed to participate in the EOI process called by any Government Department in Andhra Pradesh for minimum of 03 years under any schemes or in any project.
- 5. The supplies made shall be invoiced on GST invoice with serial No. of Invoice printed on it. No invoice other than Tax invoice will be accepted. GST applicable, if any, shall be clearly mentioned in the Tax invoice.
- 6. The manufacturers participating in the EOI should indicate the details of dealers in the EOI Schedule prescribed. The name of the Manufacturing Company once included in the approved list will not be deleted up to the end of the financial year unless felt by the APSAIDCL.
- 7. The approved manufacturing company shall supply ordered tractors along with accessories like Bumper, Draw Bar, Hydraulic Hitch, Hydraulic Pipe connecting to Trailer without fail.
- 8. The approved Manufacturing Company shall supply the ordered Tractors as per terms and conditions within the stipulated time indicated in the purchase order placed from time to time to the beneficiary at end customer point and obtain acknowledgement from the beneficiary on the day of delivery.
- 9. The Tractors supplied must be covered with warranty for one year from the date of supply against any defective manufacture/workmanship etc., at suppliers own cost. Repairs/Replacements/servicing shall be attended at customer's place during the warranty period at free of cost within 07 days from date of intimation. They shall also ensure that all the components shall be made available through dealers' network at least for a period of three years from the date of supply of the unit on payment basis.
- 10. If the supplying Manufacturing Company's fail to supply the Tractors as per the supply program mutually agreed upon by both parties. the action will be initiated as per procedure.
- 11. Liquidated damages will be levied at the rate of 0.5% of the total value of work per week up to a maximum of 5% in case of default in the supply of Tractors as per schedule.
- 12. The supplier has to show the demonstration of the Tractors to the party, at the time of supply. The Manufacturing Company has to educate the concerned beneficiaries on dos and don'ts of operation of Tractors.
- 13. The acknowledgement (Proof of Delivery) and other required documents for the Tractors delivered should be signed by the end user and countersigned by the concerned officials of end user.
- 14. The transportation loading, un-loading charges and demonstration expenses should be borne by the supplier only (transits insurance).

- 15. The manufacturer shall provide detailed operational and maintenance Manuals parts catalogue (in the Telugu language) at the time of supply of the Tractors to the beneficiaries and awareness should be created to beneficiaries about the machinery. The Manufacturing Company should also supply two copies of such operational and maintenance manuals to the Corporation for official use.
- 16. The manufacturer shall provide TR, insurance for 01 year for all the Tractors.
- 17. The Engine number and any other unique number indicated on the Tractors should be communicated along with delivery challan to the end customer point.
- 18. A.P State Agro Industries Development Corporation Limited reserves the right to award offered Tractors either in part or full or to empanel on rate contract or follow any other suitable procurement procedure. AP Agros at its sole discretion and without assigning any reason thereof, reserves the right to accept / reject any or all bids at any stage of the EOI process.
- 19. In case of any dispute or difference arising out of the agreement between the two parties relating to any aspect of the agreement, the parties should attempt to settle the dispute through mutual consent and amicable discussions. If the dispute is not settled through such discussions, the matter shall be referred / settled as per provisions of Arbitration & Conciliation Act.1996.
- 20. It is further to be agreed by both the parties that all differences and disputes if not resolved as above, shall be got remedied through the Court of Law of Guntur jurisdiction only.
- 21. EOI can be rejected at any stage of the procurement process, if it comes to knowledge that any Manufacturer(s) is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others.
- 22. The approved Manufacturing Company / Manufacturing Company's shall enter into an agreement with the Corporation duly incorporating all the above terms and conditions.
- 23. The corrections, if any, must be signed by the applicant before submission itself. In the event of faulty information, the EOI is liable for rejection.
- 24. The Applicant should sign on each and every page of the application and on all the additional documents submitted.
- 25. A prospective Manufacturing Company requiring any clarification on EoI documents may contact the EoI Inviting Officer at the address indicated in the EOI.
- 26. **Pre-Bid meeting:** Any pre-bid meeting shall be confined only for clarifications.
- 27. Any addendum/amendments issued by the EoI Inviting Authority, the A P

Agro Industries, shall be part of the EoI Document and it shall be communicated through our website i.e., www.apagros.org

- 28. All documents relating to the EoI shall be in the English Language only.
- 29. If any supporting certificates i.e. the purchase/work orders and commissioned reports are in any other language, they are to be translated into English language and submitted duly certified by Notary.
- 30. The Successful manufacturer/supplier shall have to provide CSR fund towards organizing exhibitions/demonstration/trainings of their machinery according to the proposals propended by this Corporation.
- 31. Defect Liability will be 2.5% of total cost applicable beyond that warranty period for next one year.

F. <u>AFTER SALES SER</u>VICE:

- 1. The Manufacturer must provide after sales service to the beneficiaries during the warranty period.
- 2. It shall be the responsibility of the Manufacturer to ensure that necessary sufficient no. of spare parts is available to the purchaser/customer of Tractors during the warranty period and afterward also. For this purpose, the Manufacturer shall keep necessary stock of such fast/slow moving parts with their respective Dealers.
- 3. The Manufacturer shall also make arrangements for repair and after sales service required on a continuous basis after the expiry of the warranty period and shall ensure that the repairs/maintenance cost incurred by the purchaser are minimum within a period of 7 days from the date of issue raised.

G. INSPECTION FOR QUALITY:

The VC & MD, APSAIDCL or their authorized representatives shall have the power:

- 1. To reject any tractor which is not being in accordance with the specifications.
- 2. To reject the Tractors if having defects portion thereof as it may, in its discretion, think fit, it is satisfied that the same is unsatisfactory. APSAIDCL is having power to inspect if found is not satisfactory.
- 3. The VC & MD, APSAIDCL or any officer authorized by VC & MD also has right to inspect the materials to be dispatched/in Transit/already delivered at anytime and anywhere.
- 4. The VC & MD, APSAIDCL also has right to inspect the raw materials used for manufacturing, the process of manufacturing, quality policy fixed, and testing facilities for the product to be supplied by the Manufacturer at the Manufacturer's premises.
- 5. <u>Cost of Test:</u> The manufacturer is liable to pay the testing charges for any Test done on the products supplied for conformity on quality.

H. Process to be Confidential.

- 1. Information relating to the examination, clarification, evaluation and comparison of EoIs and recommendations for the award of a empanelment shall not be disclosed to Manufacturing Companies or any other persons not officially concerned with such process until the award to the successful Manufacturing Company has been announced by the EoI accepting authority. Any effort by a Manufacturing Company to influence the processing of EoIs or award decisions may result in the rejection of EoI.
- 2. No Manufacturing Company shall contact the EoI Inviting Authority, or any authority concerned with finalization of EoIs on any matter relating to its EoI from the time of the EoI opening to the time the empanelment is awarded.
- **3.** Before recommending / accepting the EoI, the EoI recommending / accepting authority shall verify the correctness of certificates submitted to meet the eligibility criteria and specifically experience.

I. Award Criteria:

- 1. The Managing Director, APSAIDCL, will award the empanelment to the successful Manufacturing Company whose EoI is approved by the EoI Approval Committee constituted.
- 2. APSAIDCL reserves the right to accept or reject any EoI or all EoIs and to cancel the EoI process, at any time prior to the award of empanelment, without thereby incurring any liability to the affected Manufacturing Company or Manufacturing Companies or any obligation to inform the affected Manufacturing Company or Manufacturing Companies of the reasons for such action.
- **3.** When a EoI is to be accepted the concerned Manufacturing Company shall attend the office of the MD, APSAIDCL Vaddeswaram on the date fixed in the Letter of acceptance.
- **4.** The successful Manufacturing Company has to approach Managing Director, Vaddeswaram, to sign an agreement APSAIDCL within a period of 7 days from the date of receipt of communication of acceptance of his EoI.
- 5. If the lowest Manufacturing Company backs out, penalty of forfeiture of Performance guarantee will be imposed and business of the agency will be suspended for one year with all the Departments in A.P in respect of conventional EoIs also vide G.O. Ms. No. 259 of T, R&B (R.V) dept., dt. 6.9.2008.

J. Corrupt or Fraudulent Practices

The Government requires that the Manufacturing Companies / suppliers / Manufacturing Companies under Government financed empanelment,

- observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Government
- (a) define for the purposes of the provision, the terms set forth below as follows:
 - 1. "Corrupt practices" means the offering, giving, receiving or soliciting of anything of value to influence the action of a government official in procurement process or in contract execution: and
 - 2. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of empanelment to the detriment of the Government and includes collusive practice among Manufacturing Companies (prior to or after EoI submission) designed to establish in EoI prices at artificial non-competitive levels and to deprive the Government of the benefits of free and open competition.
- (b) Will reject a proposal for award if it determines that the Manufacturing Company recommended for award has engaged in corrupt or fraudulent practices in competing for the empanelment in question.
- (c) Will blacklist / or debar a Manufacturing Company, either indefinitely or for a stated period of time, if at any time determines that the Manufacturing Company has engaged in corrupt or fraudulent practices in competing for, or in executing a government empanelment.
- (d) Furthermore, Manufacturing Companies shall be aware of the provisions stated in the General Conditions of empanelment.

K. Modes of Settlement of claims/disputes & place of exclusive jurisdiction:

- 1. If any claim, dispute or disagreement of any kind whatsoever arises between.
- 2.1. the Manufacturing Company and the APSAIDC Ltd., in connection with or arising out of or touching upon this empanelment, including without prejudice to the generality of the foregoing, any question regarding its existence, validity, termination, or execution, whether before or after the termination, abandonment or breach of this empanelment ("Dispute"), the Parties will seek to resolve the Dispute by mutual consultation, within 30 (thirty) days from the occurrence of such dispute.
- 2.2. If the Parties fail to resolve the Dispute by mutual consultation within 30 (thirty) days after notice of the Dispute by one Party to the other Party, then, the provisions of clauses will apply:
- 2.3. If any Dispute is not resolved by the Parties pursuant to Clause-I within 30(thirty)days of the notice of the Dispute, then either Party may provide notice to the other Party, of its intention to commence

arbitration, as hereinafter provided, as to the matter in Dispute, and no arbitration in respect of the said Dispute will be commenced unless such notice is provided.

- 2.4. The expenses in internal arbitration shall be borne by respective parties and expenses and fees of the sole Arbitrator(external) shall be borne equally by both parties subject to final decision on costs by sole external Arbitrator. The fee is as per Schedule IV of the Arbitration Act, in addition to the remuneration payable to the ICADR or any other institution.
- 2.5. The arbitrator shall give a reasoned award & same is governed by the provisions of Arbitration Act-1996 amended from time to time for either finality or execution or enforcement as the case may be.

L. <u>TERMS OF PAYMENT</u>:

- 1. The APSAIDCL will make advance payment on request of successful Empaneled Manufacturer.
- 2. Name of the service dealer and contact number may be furnished on the invoice of the Manufacturing Company.

I/We have gone through the terms and conditions governing this empanelment and I/we would abide by the terms and conditions laid down in the application for supply of the Tractor model quoted.
