A. <u>Preamble:</u>

Different Government organizations requested to supply **different sizes of HDPE Drums, PHEROMONE TRAPS & LURES, YELLOW STICK PLATES** to the farmers in the State of Andhra Pradesh through A.P.S.Agro Ind. Dev. Corp. Ltd. (APSAIDCL), a Government of Andhra Pradesh undertaking.

EOI Schedules & Price Quotes are invited for empanelment of manufacturers for supply of **different sizes of HDPE Drums, Pheromone Traps & Lures, Yellow Stick Plates**.

B. <u>ELIGIBLE CONDITIONS FOR OFFERER(S)</u>:

- The Offerer(s) shall be a manufacturer of HDPE Drums, Pheromone
 Traps & Lures, Yellow Stick Plates, the offerer should have minimum
 Rs.1.00 crore turnover in any field for the last three financial years.
- The manufacture should produce the manufacturing license. The Offerer

 (s) shall have a full fledged manufacturing unit with sufficient personnel
 for manufacturing of HDPE Drums, Pheromone Traps & Lures,
 Yellow Stick Plates as per the prescribed specifications.
- 3. The Offerer(s) shall have full fledged distribution network in Andhra Pradesh State to attend the post sales service.
- 4. The firm shall have GST, Registration and PAN number and firms regularly furnishing information to Sales Tax Department online.

C. INSTRUCTIONS FOR SUBMISSION OF EOI SCHEDULE:

- 1. The Offerer (s) should submit Memorandum and Article of Association of companies or partnership deed
- 2. List of partners/Director of the company/ firm with designation phone number, Email id Fax
- 3. GST Registration certificate
- 4. The offerer should enclose Annexure-I in a separate sealed cover duly superscribing EOI Schedule for supply of "HDPE Drums, Pheromone Traps & Lures, Yellow Stick Plates" along with check list and concerned self attested certificates, EOI Schedule, covering letter enclosing schedule cost of Rs.5000/- in shape of Demand Draft. Price Quote as per Annexure-III in a separate sealed cover duly superscribing "Price Quote for supply of HDPE Drums, Pheromone Traps & Lures, Yellow Sticky Plates" with name and address of the Offerer. Both covers are to be placed in a third cover duly super-scribing "EOI Schedule for supply of "HDPE Drums, Pheromone Traps & Lures, Yellow Sticky Plates".
- The Offerer (s) shall submit duly notarized declaration along with EOI, as per the proforma furnished under Annexure-IV on Rs.100/- Non-Judicial stamp paper.
- 6. The authorized person representing the firm who is signing on the EOI documents and also participating in the EOI opening shall invariably attach a copy of authorization letter from the competent authority of the firm as per the Bye-laws of the firm / Company.
- 7. The last date for submission of EOI schedule is 04-05-2023 upto 3.00 p.m. The technical EOI Schedule will be opened at 3.30 p.m. on the same day. The price quotation will be opened at 4.30 PM followed by price negotiations.
- 8. The manufacturer should have service centers in **Andhra Pradesh**

D. GENERAL TERMS AND CONDITIONS:

- 1. The Offerer(s) have to quote the prices only as per the technical specifications given in the EOI schedule in Annexure II.
- 2. The **Expression Of Interest** (EOI) applications can be download from AP Agros web site: www.apagros.org
- 3. The Price Quote of only those Offerer (s) Technical EOI Schedules are qualified will be opened.
- 4. Negotiations will be held as per the decision of the Technical Committee.
- 5. The agreement period will be up to 31.03.2024 from the date of signing the agreement. No Escalation charges will be paid for supply of equipment during the agreement period. Failure to supply the material due to price variation will attract blacklisting of the firm and shall not be allowed to participate in the EOI process called by any Government Department in Andhra Pradesh for minimum 3 years.
- 6. The approved firms shall supply the ordered material as per terms and conditions within the stipulated time indicated in the purchase order placed from time to time to the beneficiary at Mandal Headquarter and obtain acknowledgement from the beneficiary on the day of delivery.
- 7. The eligible suppliers may empanel at any time before 10-03-2024. We will intimate the date of negotiations by mail or phone.
- 8. The supplies made shall be invoiced on GST invoice with serial No. of Invoice printed on it. No invoice other than Tax invoice will be accepted. GST applicable, if any, shall be clearly mentioned in the Tax invoice.

- 9. The manufacturers who are participating in the EOI should indicate the details of dealers in the EOI Schedule. The dealer should have GST numbers. The name of the firm once included in the approved list will not be deleted up to the end of the financial year unless felt by the tendering agency.
- 10. The approved firms shall supply the ordered equipment as per terms and conditions within the stipulated time indicated in the purchase order placed from time to time to the beneficiary at end customer point and obtain acknowledgement from the beneficiary on the day of delivery.
- 11. The equipment supplied must be covered with warranty for one year from the date of supply against any defective manufacture / workmanship etc., Repairs / Replacements / servicing shall be attended at farmer's place during the warranty period at free of cost within 7 days from date of intimation. They shall also ensure that all the components shall be made available through dealers network at least for a period of three years from the date of supply of the unit on payment basis.
- 12. Liquidated damages will be levied at the rate of 0.5% of the total value of work per week up to a maximum of 5% in case of default in the supply of equipment as per schedule.
- 13. The supplier has to show the demonstration of the equipment to the party, before taking signature from the party on Utilization Certificate. The firm has to educate the concerned Department employees on do's and don'ts of operation of equipment. The firm should submit the utilization certificate within one week after delivery of the equipment.
- 14. The acknowledgement (Proof of Delivery) and other required documents for the equipment delivered should be signed by the

beneficiary and countersigned by the **concerned officials of end customer point.**

- 15. The loading, un-loading charges and demonstration expenses should be borne by the supplier only (transits insurance).
- 16. AP Agros at its sole discretion has right to empanel more Offerer(s) other than the Offer found as L-1 also, so as to enable the corporation to ensure adequate supply of material on time as the material is required to be supplied within the season. Further A.P Agros without assigning any reason thereof, reserves the right to accept / reject any or all offers at any stage of the EOI process.
- 17. In case of any dispute or difference arising out of the agreement between the two parties relating to any aspect of the agreement, the parties should attempt to settle the dispute through mutual and amicable discussions. If the dispute is not settled through such discussions, the matter shall be referred / settled as per provisions of Arbitration & Conciliation Act.1996.
- 18. It is further to be agreed by both the parties that all differences and disputes if not resolved as above, shall be got remedied through the Court of Law of Hyderabad jurisdiction only.
- 19. EOI can be rejected if at any stage of the procurement process, it comes to knowledge that any Offerer(s) is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others.
- 20. The offerer shall be liable for blacklisting and prosecution, if they fail to adhere to the above conditions.

21. The approved firm / firms shall enter into an agreement with the Corporation duly incorporating all the above terms and conditions.
