 - g. The agreement period will be up to 31.10.2023 from the date of signing the agreement. No Escalation charges will be paid for supply of equipment during the agreement period.
 - h. The equipment supplied must be covered with warranty for one year from the date of supply against any defective manufacture / workmanship etc.,
 - i. If the supplying firms fail to supply the equipment within the scheduled time i.e.21 (Twenty One) days from the date of receipt of purchase order, the action will be initiated as per procedure and alternate arrangements will be made.
 - j. Liquidated damages will be levied at the rate of 0.5% of the total value of work per week up to a maximum of 5% in case of default in the supply of equipment as per schedule.
 - k. The purchaser shall takeout and keep in force the various insurances contemplated i.e., marine/theft/fire etc., from the port where the goods

- dispatched i.e., from FOB to the port at which goods received i.e., to say the seller should hold responsible till the shipment i.e., (till the dispatch of goods).
- l. The manufacturer shall provide detailed operational and maintenance Manuals parts catalog (in the English language) at the time of supply. The firm should also supply and maintenance manuals to the Corporation
- m. The serial number and any other unique number indicated on the equipment should be communicated in advance.
- n. A.P State Agro Industries Development Corporation Limited reserves the right to award offered equipment either in part or full or to empanel on rate contract or follow any other suitable procurement procedure. AP Agros at its sole discretion and without assigning any reason thereof, reserves the right to accept / reject any or all bids at any state of the EOI process.
- o. - q. EOI can be rejected if at any stage of the procurement process, it comes to knowledge that any Offerer(s) is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others.
- r. The manufacturer/supplier shall be liable for blacklisting and prosecution, if they fail to adhere to the above conditions.
- s. The approved firm / firms shall enter into an agreement with the Corporation duly incorporating all the above terms and conditions.
- t. The Offers received after due date and time & incomplete offers are liable to be summarily rejected.

5.PAYMENT PROCEDURE:

Purchaser shall arrange irrevocable letter of credit with a prime bank to be established in favour of seller for the full amount of the contract immediately upon the conclusion of each contract. Seller must receive the 1st irrevocable L/C within 15 days on signing. The amount of 1st L/C should be for 2000 numbers and the remaining should be on mutually agreed terms. 1st shipment will be within 15 days on receipt of L/C.

6.ACCEPTANCE OF TENDER:

In case of any dispute or difference arising out of the agreement between the two parties relating to any aspect of the agreement, the parties should attempt to settle the dispute through mutual and amicable discussions. If the dispute is not settled through such discussions, the matter shall be referred / settled as per provisions of Arbitration & Conciliation Act.1996. In the event of dispute, difference or a contention over the interpretation or meaning of the terms of the contract or reasonable inference there from, both parties shall promptly make endeavor to resolve the dispute or differences by mutual discussions and Agreement. Should the dispute or difference continue to remain unresolved, both parties each nominate a person to negotiate and reconcile the dispute or difference to resolve thereby the matter of contentions between the parties arising out of contract. In the event, that these persons referred to cannot Agreement, they shall nominate a neutral person to reconcile the dispute or difference. In case, the two persons cannot Agreement on 3rd Neutral person, or in the case of efforts of neutral person nominated by both the parties to resolve within 6 months did not fructify both parties to the contract should proceed to arbitration as provided herein:

- a. Pending resolution of any such claim or dispute, the seller and purchaser should perform their obligation as per the terms of contract.
- b. The Arbitration shall be at Vijayawada and all the proceedings should be in English language and the governing laws shall be in accordance with the law a suitable to the contract, the law of the country to be agreed to, and in conformity to the laws of country where the purchaser resides.
- c. The Aribtrator should be appointed and a mutual consent of both parties or by their agent and he the sole arbitrator should be preferably well versed with the technical know-how or well versed in the field neither employee nor agent of both the parties. He should be a an independent person.

11. Jurisdiction of Courts:

The court of the place from where the contract has been issued shall alone have jurisdiction to decide the issue if any dispute arising at of or in respect of contract.


