B. ELIGIBLE CONDITIONS FOR OFFERER(S) :

1. Those having valid manufacturer Certificate Part II or 3 completed years of experience with workshop license for manufacturing as specified in the schedule for supply of different types of equipments.
2. The manufacturers should submit the recent Registered invoices before 03 months anywhere in India.
3. The Offerer(s) shall have a full fledged manufacturing unit with sufficient personnel for manufacturing of above equipments as per the prescribed specifications.
4. The Offerer(s) shall have full fledged distribution network in Andhra Pradesh to attend the post sales service.
5. The Offerers shall have GST, Registration and PAN number and firms regularly furnishing information to Sales Tax Department online.
6. The downloaded EOI Schedules received without Demand Draft for Rs.5,000/- drawn in favor of APS Agro. Ind. Dev. Corp. Ltd., Payable at Vijayawada in technical quotation cover towards cost of EOI schedule will be rejected.
7. The importers who are importing the above equipments from any country should have valid import license and should submit a letter from the manufacturer (principle) should mention country of origin.

C. INSTRUCTIONS FOR SUBMISSION OF EOI SCHEDULE:

The Offerer(s) shall submit EOI Schedule with all documents indicated in Annexure-II in a separate sealed cover duly superscribing EOI Schedule for **“Self Propelled Back Hoe Loader, Reapers, Raised bed planters, Seed cum Fertiliser drills, Oil Engines, Solar Pest Traps, Multi crop Thresher, Garden Tools, Banana Bunch covers, Fogging machines, Sprayers, Tyres & Tubes, Batteries, Post Hole Digging machines, Brush Cutters, Animal Feed Machines, Animal Feed cum Pellet Machines, Biomes Pellet Machines, Floating Fish Feed Machines, Hammer cum Crusher Mills, Cyclone Grinders, Pulverisers, Mini Rice Mills, Mixer Machines, Charcoal Machines, Rotovators, Roto Puddlers, Bailers, Rotavator Blades & Bolts, Hydraulic Reversible Ploughs, Chaff Cutters, Super Seeders, Tarpaulins”** and Price Quote as per Annexure-III in a separate sealed cover duly superscribing “Price Quote for above equipments” with name and address of the Offerer. Both covers are to be placed in a third cover along with covering letter and demand draft of Rs.5,000/- as stipulated under Item of the Instructions for Submission of EOI Schedule duly superscribing “EOI Schedule for “above equipments”.

1. The Offerer(s) shall submit duly notarized declaration along with EOI, as per the proforma furnished under Annexure-IV on Rs.100/- Non-Judicial stamp paper.
2. The authorized person representing the firm who is signing on the EOI documents and also participating in the EOI opening shall invariably attach a copy of

authorization letter from the competent authority of the firm as per the Bye-laws of the firm / Company.

3. The manufacturers/Importers who are having dealers & service centers in Andhra Pradesh is only eligible to participate in the EOI.

D. GENERAL TERMS AND CONDITIONS :

1. The Expression of Interest (EOI) applications can be downloaded from 01-07-2022.
2. The Offerer(s) have to quote the prices only as per the technical specifications of their products.
3. Negotiations will be held as per the decision of the Technical Committee at the address indicated in the data sheet. The aim is to reach agreement on all the points and sign a contract.
4. The agreement period will be up to 31.3.2023 from the date of signing the agreement. No Escalation charges will be paid for supply of equipment during the agreement period. Failure to supply the equipment due to price variation will attract blacklisting of the firm and shall not be allowed to participate in the EOI process called by any Government Department in Andhra Pradesh for minimum 3 years under any schemes or in any project.
5. The eligible suppliers may empanel at any time before 28-02-2023. We will intimate the date of negotiations by mail or phone.
6. The supplies made shall be invoiced on GST invoice with serial No. of Invoice printed on it. No invoice other than Tax invoice will be accepted. GST applicable, if any, shall be clearly mentioned in the Tax invoice.
7. The manufacturers who are participating in the EOI should indicate the details of dealers in the EOI Schedule. The dealer should have GST numbers. The name of the firm once included in the approved list will not be deleted up to the end of the financial year unless felt by the tendering agency.
8. The approved firms shall supply the ordered equipment as per terms and conditions within the stipulated time indicated in the purchase order placed from time to time to the beneficiary at end customer point and obtain acknowledgement from the beneficiary on the day of delivery.
9. The equipment supplied must be covered with warranty for one year from the date of supply against any defective manufacture / workmanship etc., Repairs / Replacements / servicing shall be attended at farmer's place during the warranty period at free of cost within 7 days from date of intimation. They shall also ensure that all the components shall be made available through dealers network at least for a period of three years from the date of supply of the unit on payment basis.
10. If the supplying firms fail to supply the equipment within the scheduled time i.e.21 days from the date of receipt of purchase order, the action will be initiated as per procedure.

11. Liquidated damages will be levied at the rate of 0.5% of the total value of work per week up to a maximum of 5% in case of default in the supply of equipment as per schedule.
12. The supplier has to show the demonstration of the equipment to the party, before taking signature from the party on Utilization Certificate. The firm has to educate the concerned Department employees on do's and don'ts of operation of equipment. The firm should submit the utilization certificate within one week after delivery of the equipment.
13. The acknowledgement (Proof of Delivery) and other required documents for the equipment delivered should be signed by the beneficiary and countersigned by the **concerned officials of end customer point**
14. The loading, un-loading charges and demonstration expenses should be borne by the supplier only (transits insurance).
15. The manufacturer shall provide detailed operational and maintenance Manuals parts catalog (in the Telugu language) at the time of supply of the equipment and awareness should be created in beneficiaries to follow the instructions. The firm should also supply two copies of such operational and maintenance manuals to the Corporation for official use.
- 15.A. The TR, permission, Transit (Insurance for 1 year) is the responsibility of the manufacturer/dealer only if applicable for self propelled back hoe loader.
16. The serial number and any other unique number indicated on the equipment should be communicated along with delivery challan to the end customer point.
17. A.P State Agro Industries Development Corporation Limited reserves the right to award offered equipment either in part or full or to empanel on rate contract or follow any other suitable procurement procedure. AP Agros at its sole discretion and without assigning any reason thereof, reserves the right to accept / reject any or all bids at any state of the EOI process.
18. AP Agros at its sole discretion has right to empanel more Offerer(s) other than the Offer found as L-1 also, so as to enable the corporation to ensure adequate supply of equipment on time as the equipment is required to be supplied within the season. Further, A.P Agros without assigning any reason thereof, reserves the right to accept / reject any or all offers at any stage of the EOI process.
19. In case of any dispute or difference arising out of the agreement between the two parties relating to any aspect of the agreement, the parties should attempt to settle the dispute through mutual and amicable discussions. If the dispute is not settled through such discussions, the matter shall be referred / settled as per provisions of Arbitration & Conciliation Act.1996.
20. It is further to be agreed by both the parties that all differences and disputes if not resolved as above, shall be got remedied through the Court of Law of Vijayawada jurisdiction only.

21. **EOI can be rejected if at any stage of the procurement process, it comes to knowledge that any Offerer(s) is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others.**
22. The manufacturer/supplier shall be liable for blacklisting and prosecution, if they fail to adhere to the above conditions.
23. The approved firm / firms shall enter into an agreement with the Corporation duly incorporating all the above terms and conditions.
24. The offerer has to furnish their authorized dealers list along with the Agreement quotation, duly enclosing a copy of acceptance letter from the dealer.

E. TERMS OF PAYMENT:

Payment will be settled after receipt of funds from concerned Department and verification of products and submitted satisfactory report by their Authorities
