- a) The offerer should have minimum Rs.1.00 Crore turnover for each of the last three consecutive financial years i.e. 2015-16, 2016-17 & 2017-18.
 - b) The offerer shall produce experience certificate in the same nature of supply for any Govt. Departments in any of the last 3 years.
2. The manufacture should produce the valid manufacturing license. The Offerer(s) shall have a full fledged manufacturing unit with sufficient personnel for manufacturing of product mentioned in ANNEXURE II as per the prescribed specifications.
 3. The manufacturer should produce agreement on Rs.100/- bond paper.
 4. The Offerer(s) shall have full fledged distribution network in Andhra Pradesh State to attend the post sales service.
 5. The firm shall have GST Registration and PAN number and firms regularly furnishing information to Sales Tax Department online.

D. INSTRUCTIONS FOR SUBMISSION OF EOI SCHEDULE:

1. The Offerer(s) shall submit Memorandum and Article of Association of companies or partnership deed.
2. The Offerer(s) shall submit List of partners / Director of the company/ firm with designation, phone number, Email id & Fax.
3. The Offerer(s) shall submit GST registration certificate
4. The Offerer should enclose Annexure-I in a separate sealed cover duly super scribing technical bid for "supply the High Pressure Cleaners (regular cleaning and maintenance of community toilets)" with check list

and concerned self attested certificates, EOI Schedule, covering letter enclosing schedule cost, EMD, an undertaking on Rs.100/- stamp paper. Price Quote as per Annexure-III in a separate sealed cover duly superscribing "Price Quote for supply the High Pressure Cleaners (regular cleaning and maintenance of community toilets)." with name and address of the Offerer. Both covers are to be placed in a third cover duly super scribing "EOI Schedule for supply of High Pressure Cleaners".

5. Earnest Money Deposit (EMD) amount of **Rs.1,00,000/-** (Rupees One lakh only) shall be paid in the form of Demand Draft drawn in favour of **A.P.S.A.I.D.C. Ltd., payable at Vijayawada** along with a covering letter. EOI Schedules without EMD will be rejected.
6. The Offerer(s) shall submit duly notarized declaration along with EOI, as per the proforma furnished under Annexure-IV on Rs.100/- Non-Judicial stamp paper.
7. The authorized person representing the firm who is signing on the EOI documents and also participating in the EOI opening shall invariably attach a copy of authorization letter from the competent authority of the firm as per the Bye-laws of the firm / Company.
8. The last date for submission of EOI schedule is up to 05-06-2018 upto 2.00 pm. The technical bid will be opened at 2.30 p.m. on the same day.
9. In the event of any date indicated above is declared as public holiday, the next working day shall become operative for the respective purpose mentioned herein.
10. The EMD of un-successful Offerer(s) shall be returned on finalization of EOI's i.e., after agreement.

11. The EMD of successful Offerer(s) shall be retained by the Corporation and refunded only after satisfactory completion of the contract. The EMD shall be adjusted against the Performance Guarantee for the successful Offerer. This deposit will not carry any interest.
12. The manufacturer should have service centers in **Andhra Pradesh**. They should indicate the details of network in Andhra Pradesh for successful implementation of programme.

E. GENERAL TERMS AND CONDITIONS :

1. The Offerer(s) have to quote the prices only as per the indicative general technical specifications given in the EOI schedule in Annexure-II.
2. The Price Quote of only those Offerer(s) whose technical bid is qualified for acceptance will be opened on 05-06-2018 at 4.00 pm.
3. Charges of material transportation to the work site, transit insurance, loading & un-loading charges should be borne by the supplier only.
4. The supplies made shall be invoiced on GST invoice in Triplicate with serial No. of Invoice printed on it. No invoice other than Tax invoice will be accepted. GST applicable, if any, shall be clearly mentioned in the Tax invoice.
5. The Panchayat Raj & Rural Development shall have right to inspect the progress and quality of work at any time.
6. The production unit of the manufacturing company shall be inspected if required by the Technical Committee constituted by the Department at its discretion for evaluating infrastructure, quality, man-power and production capacity to assess the ability of the company to supply the quoted quantity before accepting the EOI and during the contract period.

7. Random inspection of all material distributed under ODF and ODF Plus activities will be conducted by suitable committee/team as appointed by the PR& Rural Development department before / after the material is supplied to the farmers and also during the installation.
8. The approved firm / firms shall enter into an agreement with the Corporation duly incorporating all the above terms and conditions.
9. The agreement period will be up to 31.3.2019 from the date of signing the agreement. No Escalation charges will be paid for supply of equipment during the agreement period. Failure to supply and installation of their material due to price variation within stipulated period (21 days) will attract blacklisting of the firm and shall not be allowed to participate in the EOI process called by any Government Department in Andhra Pradesh.
10. Performance Guarantee deposit of Rs.**2,00,000/-** shall be paid in the Shape of Demand Draft drawn in favour of A.P.S.A.I.D.C Ltd., payable at Vijayawada at the time of agreement. This deposit will not carry any interest and shall be paid before entering into contract agreement on Rs.100/- non-judicial stamp paper duly notarized.
11.
 - a) Performance guarantee produced by the successful offerer shall be forfeited & alternate arrangements shall be made, if the firm does not fulfill the obligation of supply of stocks as per orders / specification / quality
 - b).Alternate arrangements will be made for procurement of such products and any additional cost incurred in this regard will be recovered from the concerned firm. This will be scrupulously followed.
 - c). The responsibility of quality and quantity (eg. Misbranding / under weight) of the material supplied lies with supplier only.

12. The manufacturer shall emboss on the sheet that the material supplied under ODF scheme of Govt. of AP.
13. In the event of any equipment failing to conform to the specifications, the Commissioner, Panchayat Raj & Rural Development Department has the right to reject the equipment and the supplier shall replace the rejected equipment with fresh stock at their own cost within the specified time given.
14. In case of complaint / defect, the supplier shall have to arrange repair / replacement of equipment within 10 days from the date of receipt of intimation.
15. The supplier has to show the quality and advantage of the equipment to the beneficiary, before taking signature from the concerned on Utilization Certificate. The firm has to educate the beneficiary on do's and don'ts of maintenance of the equipment.
16. The manufacturer shall be liable for black listing and further prosecution, if he fails to adhere to the general terms and conditions.
17. Liquidated damages will be levied at the rate of 0.5% of the total value of work per week up to a maximum of 5% in case of default in the supply of material as per schedule.
18. Any complaint received from the beneficiary, through concerned AP Agros or Panchayat Raj & Rural Development Department should be forwarded to the Successful Offerer and the Successful Offerer should rectify the defects within a period of 15 days from the date of receipt of complaint or otherwise the penalty may be imposed as follows:
 - a. More than 15 Days – Rs.10,000/-
 - b. More than 30 Days – Rs.25,000/-
 - c. More than 45 Days – Rs.50,000/-
 - d. More than 60 Days the Successful Offerer may be black listed without any notice.

19. The Department reserves the right to pre-pone or post-pone or cancel the EOI in part or full without assigning any reason.
20. The agreement can be cancelled at any stage of the execution process, if it comes to knowledge that the supplier is involved in any fraudulent practice or misrepresentation of the facts or tries to influence the selection process or indulges in any corrupt activities.
21. AP Agros at its sole discretion has right to empanel more Offerer(s) other than the Offer found as L-1 also, so as to enable the Corporation to ensure adequate supply of material on time as the material is required to be supplied within the season. Further A.P Agros without assigning any reason thereof, reserves the right to accept / reject any or all offers at any stage of the EOI process.
22. EOI can be rejected if at any stage of the procurement process, it comes to knowledge that any Offerer(s) is involved in any fraudulent practice or misrepresentation of the facts or tried to influence the selection process or indulged in any corrupt activities in competing with others.
23. In case of any dispute or difference arising out of the agreement between the two parties relating to any aspect of the agreement, the parties should attempt to settle the dispute through mutual and amicable discussions.
