In continuation to the Proceedings issued mentioned under reference 1<sup>st</sup> & 2<sup>nd</sup> cited, wherein Orders issued bifurcating the Officers/staff working at HO in the erstwhile A.P.State Agro Industries Development Corporation Ltd., between two separate entities formed after completion of the bifurcation process as per guidelines issued in the A.P.Reorganization Act, 2014, now it is decided to communicate the final allocation list of officers/employees among the two separate entities viz., A.P.State Agro Industries Development Corporation Ltd., and Telangana State Agro Industries Development Corporation Ltd., as on 02-06-2014 i.e., as on the 'Appointed Day' of formation of new State 'Telangana' in compliance to the directions issued by the Board of Directors in their 261<sup>st</sup> Meeting held on 18.05.2015.

In this connection it is to inform that in pursuance to promulgation of A.P.Reorganization Act, 2014, two separate divisions namely 'Andhra' and 'Telangana' are formed w.e.f. 02.06.2014 as per the guidelines issued by the Government from time to time. The existing sanctioned posts as on 02.06.2014 in the erstwhile A.P.State Agro Industries Development Corporation Ltd., are allocated between the two State Units based on the population ratio in the Demerger Plan. Similarly, the employees are also allocated to the two State Units on provisional basis in the Demerger Plan. The Demerger Plan was approved by the Board of Directors in their 261<sup>st</sup> Meeting held on 18.05.2015 and the same was submitted to the Expert Committee. The Board of Directors in their 261<sup>st</sup> Meeting authorized the VC & MD to initiate action for final allocation of the employees as on 02.06.2014 between the two successor State Units based on their nativity as per Presidential Order.

In consonance of the directions of the Board of Directors, it is decided to communicate the final allocation lists of employees as on 02.06.2014 among the two successor Units viz., M/s A.P.State Agro Industries Development Corporation Ltd., in **Annexure-I** and M/s Telangana State Agro Industries Development Corporation Ltd., in **Annexure-II** as per Section 82 of the A.P.Reorganization Act, 2014 basing on the personal credentials already submitted by all the Offices/staff working in the Corporation declaring their nativity as per the Provisions of Presidential Order.

The Controlling Officers of both successor State Corporations viz., M/s A.P.State Agro Industries Development Corporation Ltd., and M/s Telangana State Agro Industries Development Corporation Ltd., are requested to bring the contents of these Proceedings to the notice of all Officers and staff working under their control along with the final allocation list of officers/employees. The final allocation lists of officers/employees along with copy of this Proceedings shall be served in person to each and every employee working under their control under proper acknowledgement and exhibit the same in the notice board of every office for vide publicity.
