**CORRIGENDUM TO TENDER ID: 933084**

1. Payment of the Earnest Money Deposit (EMD) shall be exempted for Micro, Small, and Medium Enterprises (MSMEs) upon uploading of a valid MSME certificate issued by the competent authority.
2. The EMD payable by bidders other than MSMEs may also be paid by a valid Bank Guarantee issued by a Scheduled Commercial Bank in India.
3. With reference to column No.6 of page No. 3 of the tender document for turnover, MSMEs with prior turnover in any one (1) year during the preceding five (5) years, to the extent of 50%, supported by valid documentary evidence, are also eligible to participate in the tender.
4. In evaluating the experience of bidders for 38 schedules, due consideration shall be given to the bidder's experience in the production and supply of the products as mentioned in each schedule to Government Departments, or Government Agencies, or private sales in any one (1) year during the previous five (5) years. The bidder shall upload valid documentary proof like Tax invoices for determining qualification under this tender.  
Relaxation in turnover for MSMEs shall also include a relaxation in experience, up to 50 % of the amount specified in each schedule of the tender document.
5. If any document is found to be fake at any stage, stringent action against the bidders concerned will be taken.
6. In Schedule-19, for the Individual Chaff Cutter, the specification is 3 blades only. All other specifications in Schedule-19 remain the same.
7. The prices quoted by bidders shall under no circumstances exceed the prices at which such bidder is offering the same products for sale in the private market. If it is established that the successful lowest evaluated bidder (L1) has supplied or offered to supply the products specified in the Schedule(s) at

a price lower than the L1 quoted price, the L1 bidder shall be obliged to supply the products to the farmer beneficiaries at such lower price. In the event of any discrepancy whereby the L1 quoted price exceeds the price at which the L1 bidder is found to be selling the same products in the private market, the lower market price shall prevail and be applied to the Contract. If the L1 quoted price is higher than the bidder's market price, the lower market price will apply.

8. The successful L1 bidder shall supply the products within 45 (fortyfive) days from the date of issue of the Purchase Order.
9. Upload of the firm's UDIN or the login credentials is accepted in respect of assessing the turnover.
10. For the upload of IT returns, FY 2020-21 is also considered.
11. Last date for submission of bids is 31.05.2026 at 5:00 PM, and the date and time of opening of technical bid is 01.06.2026 at 1:00 PM.

Therefore, it is requested to incorporate the Corrigendum and initiate/enable the provision for online submission of bids in the AP e-Procurement Portal for the above tender.
